- 1.0 Circular Letter (CL) 2024-13 dated 17 September 2024 prescribes the guidelines in the processing of requests for the release of funds to cover requirements for PS deficiencies in FY 2024.
- 2.0 Pursuant to Section 54 of the General Provisions (GP) of the FY 2024 General Appropriations Act and the aforementioned CL, the DBM ROs and the BMB-F are advised to adhere to the following procedures for decentralized departments, particularly for DepEd:
  - 2.1 Remind all units under the decentralized departments (i.e., DepEd) of the following sources per items 3.1 and 3.2 of the CL to cover deficiencies in salaries, bonuses, allowances, associated premiums, among others, i.e. i) Available PS allotments realized from unspent compensation/benefits of employees, and ii) Any FY 2024 unreleased PS appropriations.
  - 2.2 In case there are no more PS allotments available after considering item 3.1 under the CL, the units under the decentralized departments (i.e., DepEd) shall submit their requests to their respective Central Offices (CO), for evaluation/ consolidation.
  - 2.3 Consequently, the CO of said decentralized departments shall submit the said budgetary request to the DBM CO, particularly to the BMB-F, pursuant to Item No. 4.2 of the same CL.
- 3.0 In view hereof, DepEd ROP is requested to come-up with a mechanism to ensure that the provisions of the CL are observed without sacrificing the timely

- release of funding requirements to cover PS deficiencies of various DepEd operating units.
- 4.0 In addition, the SDOs are enjoined to discontinue endorsing the special budgetary requests to cover requirements of PS deficiencies (e.g. funding requirements for filling up of positions, monetization of leave credits, terminal leave benefits, clothing and uniform allowance, Philhealth and Pag-ibig deficiencies) chargeable against the FY 2024 New School Personnel Positions, effective immediately until the end of FY 2024.
