## 13th BAGO CITY INVITATIONAL FANCY DRILL COMPETITION

### Rules and Guidelines

1. Competition is open to CAT/ROTC units in both public and private schools in Negros Island Region and Western Visayas. A certification shall be submitted certifying that participants are bona fide students of the school.
2. All participating units must be in their gala uniform, with the exception of first-timers, who may be allowed to wear any type of uniform.
3. The competing units shall be a platoon size of four squads, with eight men per squad and a platoon leader. The platoon leader may be accompanied by an XO and/or a Guidon bearer.
4. The platoon leader shall be designated by the CAT/ROTC commandant or facilitator/instructor.
5. Each unit is given a minimum of ten (10) minutes and a maximum of fifteen (15) minutes, including entrance and exit, for its presentation. The designated time shall start and end with the response salute of the chairman of the board of judges. A deduction of one (1) point will be made for every minute of overtime.
6. A base drum and a snare may be used to keep the unit in cadence; tape or CD music needed during any part of the presentation will be allowed. The unit shall be responsible for making its own arrangements for this purpose.
7. The use of actual explosives and pyrotechnics is prohibited.
8. The order of presentation will be determined at 7:00 in the morning of November 5. Commandants shall draw lots at the designated assembly area. If commandants are not able to draw a number on schedule, their unit shall be disqualified from the competition.
9. The competition will start with a fancy street drill at 7:30 in the morning along the city streets and the actual performance at the City Coliseum at 1:00 in the afternoon. If the participating unit is late for the performance, it is deemed disqualified.
10. All participating units shall march from the designated assembly area and shall perform in the three judging areas determined by the fancy drill committee until the end of the parade. In no way shall the participating groups halt while the parade is ongoing. The committee shall designate personnel to check the performance of each group during the entirety of the street fancy drill. One point is deducted for every five violations.
11. During the Street Fancy Drill, participating units shall be given a maximum of two (2) minutes to remain in the designated judging area to execute their performance. The committee shall give the movements to be executed in the judging areas.

#### *Street Fancy Drill Judging Areas:*

1. Fronting Bago City Public Market
2. Fronting Araneta Monument
3. Bantayan Park Stage

*The scores will be based on the following criteria:*

1. Unit Discipline- 25 points
2. Creativity of Formation- 25 points
3. Execution- 40 points
4. Overall Impact- 10 points

*Note: Thirty percent (30%) shall be taken from the street fancy drill in the morning and 70% from the actual performance in the afternoon.*

12. The CAT/ROTC Commandant, Facilitator, or Instructor shall take care of bringing their units into the competition area and returning to their stations without cost to the organizers.
13. The organizer shall not be responsible for any injury or damage to or incurred by the participating units unless the organizer is the direct cause of such injury or damage.
14. The decision of the Board of Judges shall be final.
15. The CAT/ROTC Unit that was adjudged champion for the last three (3) consecutive years cannot join in the following year of the competition.

#### **Procedure for the Arena Competition**

1. Once the name of the unit is announced or called, it shall march and halt at the designated marker in front of the judges. The platoon leader shall present the unit to the chairman of the Board of Judges, indicating the name of the unit and its readiness to begin the drill.
2. After the chairman has acknowledged the salute, the unit commander begins the presentation and continues until it is finished.
3. The "Pass-in-Review" will indicate the completion of the presentation.
4. The decision of the board of judges will be announced immediately after completion.
