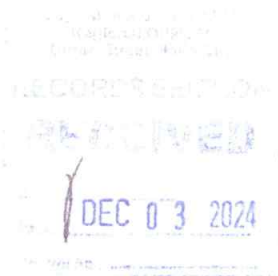

Class of 2024	The play addresses the complexities of adolescence, highlighting the significance of friendship, making positive life decisions, and resisting peer pressure in the context of anti-drug awareness.	Grades 4–12
<i>Reyna (Cleopatra, Heart of a Queen)</i>	The play seeks to redefine the story of Cleopatra, advocating for a more nuanced understanding of women's historical roles and the importance of recognizing diverse female leadership and contributions in the context of gender equality and historical representation.	
Catsville: The Musical	The play underscores the values of love, compassion, and forgiveness through the competition among feline teams, teaching the importance of these virtues in overcoming rivalry and adversity in the context of love and forgiveness.	Grades 4–7
Romeo and Juliet	The classic play by William Shakespeare addresses the consequences of familial conflict, promoting themes of understanding, reconciliation, and the importance of peace in resolving differences in the context of conflict resolution and peace.	Grades 8–12
