

The Philippine Statistics Authority (PSA), as the lead implementing agency of the Philippine Identification System (National ID), is continuously conducting registration in the province of Aklan to enroll the remaining unregistered population of the whole province (all ages, including aged below one year old) in the National ID System.

Section 2 of Republic Act (RA) No. 11055, also known as the "Philippine Identification Act," established the National ID as the single national identification system for citizens and resident aliens of the country to promote seamless service delivery, enhance efficiency and transparency, and ensure the targeted delivery of public social services.
