- a. LAN is the main backbone infrastructure where all IP services like CCTV, Telephone, Wi-Fi Access & PC networks will be embedded.
- b. Internet Connection
  - i. Dedicated Bandwidth with 1:1 ratio (15mb download and upload)
  - ii. 24/7 IT and after sales support
  - iii. With redundancy in connection
- c. Wi-Fi Access is a technology that allows electronic CPEs to connect to the internet or other hotel resources through wireless devices.

**2.**Supplier, as a service provider, undertakes to provide the Client supply and installation of Backbone network, and WIFI.

- **a. SUPPLIER** shall provide Dedicated Bandwidth with 1:1 ratio (15mb download and upload), 24/7 IT and after sales support and with redundancy in connection.
- **b. SUPPLIER** shall provide Local Area Network (LAN) supply & installation.
- c. SUPPLIER shall provide WIFI access supply & installation
- **d. SUPPLIER** shall provide all the documentations & as-built design upon completion of the project.
- e. SUPPLIER will provide 1-year warranty for factory defect equipment and after sales service within the warranty period, thereafter the warranty period SUPPLIER is not liable and/or obliged to respond in any maintenance concerned of the project unless a Maintenance Agreement will be signed in a separate contract.
- **f. SUPPLIER** shall be held liable for any delay in or failure of performance of their respective obligations set hereunder if such delay or failure arises from or is the consequence of force majeure; provided it has taken proper precautions, due care and reasonable alternative measures to avoid or otherwise minimize the delay or failure; provided, further, that any party claiming benefit of the terms set herewith shall within five (5) calendar days from the occurrence of force majeure give notice thereof to the other party including sufficient information as to the cause. Force majeure shall not however excuse the Client from the non-payment of its monetary obligations under this project.
