The programs are designed for a diverse range of learners, including junior high school students, senior high school graduates looking for TESDA-certified vocational training, out-ofschool youth seeking employable technical skills, professionals and career shifters wanting to reskill or upskill in emerging fields, industry workers pursuing certifications to advance in their current jobs, entrepreneurs and freelancers aiming to enhance their technical know-how, and partner institutions and companies seeking customized workforce development programs.
