**2025 NATIONAL TECH-VOC DAY CELEBRATION**

To: Schools Division Superintendents  
All Others Concerned


1. Pursuant to Republic Act No. 10970, an Act Declaring the Twenty-Fifth Day of August of Every Year as the National Tech-Voc Day, this Office encourages public and private elementary and secondary schools and offices to observe the 2025 National Tech-Voc Day.
2. The purpose of this celebration is to emphasize the importance of technical-vocational education through providing a platform for the exchange of information, updates, and sharing of best practices related to technical-vocational education programs. It also serves to promote and raise awareness of the various technical-vocational education offerings available in schools such as Edukasyong Pantahanan at Pangkabuhayan/Technology and Livelihood Education (EPP/TLE), Senior High School Technical-Vocational Livelihood (SHS-TVL) Track, Maritime, Work Immersion Program, Special Program in Technical-Vocational Education (SPTVE), and Farm Schools.
3. For this year, the activities will be held from August 18-29, 2025. The Curriculum and Learning Management Division, encourages all schools and division offices, in coordination with other relevant agencies and partner industries to organize activities such as forums, seminars, mentoring sessions, skills showcase, mini-courses for parents, teachers, and school employees, product and services display showcase, job fair and other related advocacy activities.
4. The expenses incurred relative to the conduct of this activity may be charged against local funds subject to existing accounting and auditing rules and regulations.
5. The teaching personnel shall be entitled to service credit during weekends and holidays in accordance with DepEd Order No. 53, s. 2023 titled "Updated Guidelines on the Grant of Vacation Service Credits." Likewise, non-teaching personnel may avail of Compensatory Time Off (CTO) for their services rendered during weekends and holidays as per Civil Service (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2 s, 2024 titled Non-Monetary Remuneration for Overtime Service Rendered on account of their direct involvement in the activity.
6. Each division is requested to submit an activity report, through email at [region6.clmd@deped.gov.ph](mailto:region6.clmd@deped.gov.ph) on or before September 5, 2025. Please see Annex 1 for the format of the activity report.
